

**TOWN OF HAMIOTA  
BY-LAW NO. 2/2003**

BEING a By-law of the Town of Hamiota providing for various appointments.

WHEREAS The Municipal Act provides that a municipality may make various appointments;

AND WHEREAS the Council of the Town of Hamiota deems it to be in the best interest of the municipality to make various appointments;
