6. Delegations: 9:30 am - Don McKibbin, P. Eng. Highways & Transportation

Don first discussed with Council the Provincial Road maintenance Program. It is the Departments wish that if municipalities wish to spend the additional 10% for road improvements they request the funding in advance. This will help the Department with cash flows. There are currently 16 agreements in Don's region. If Council wants to have a project considered the Department staff will come out and review each proposal with Council.

Don then discussed placement of a culvert through Highway 21 North of Oakner. Don understood that the municipality would get the water rights licence and pay to push the culvert through the highway. The Department would pay to purchase the culvert. Council indicated that pushing the pipe through the highway was going to cost significantly more than the culvert and it would prohibit the work from being completed. Don agreed that the deal should be a 50-50 split on the costs. His staff would review the project and its costs and get back to Council in a couple of weeks.
