Rick was before Council to update them on the violations that have happened throughout the municipality in particular around the Six-Mile-Slough. His direction from his superiors is to pursue all of the outstanding files and have the works closed off by freeze up. Land owners who did the work will be given an order to lose the subject drainage. New owners were given letters and asked to comply but ultimately they will have to.

Anyone who doesn't comply will have the Province enter their lands and do the work.

Once Rick has completed this task he will return to his area in Little Saskatchewan and West Souris C.D.'s, Bob Brudy out of Shoal Lake will look after complaints and licences in this area. Ed McKay is back in the Brandon Office where there are currently 3 people. There is one person in Deloraine and hopefully one in Neepawa in the future.

11:10 am – Dale Little and Perry Longmuir

The delegation was before Council to discuss proposed drainage works southeast of the Six-Mile-Slough. Dale felt that the proposed works did not go far enough and because of the generally flat nature of the land the water will not flow. The land does drop off to the south which is where the water seems to want to go. There will have to be a block installed to prevent this from happening and flooding other properties.

The CAO will contact Water Stewardship to see what can be done as maintenance and other options that may be available to the landowners. Council thanked the delegation for their time.
