***WHEREAS overland flooding in Manitoba has become the most serious problem for the majority of Manitobans due to the millions of dollars lost each year whether by damage to personal and business property or the loss of production on agricultural lands;***

***AND WHEREAS municipalities are faced with the task of working with local landowners to come up with solutions to this problem while at the same time complying with legislation and regulations that the Federal and Provincial Governments are insisting on;***

***AND WHEREAS it is more common for feasibility studies containing technical information that can only be done by professional consultants to be required before a Water Rights License can be obtained to do any work;***

***NOW THEREFORE BE IT RESOLVED THAT the Council of the Rural Municipality of Hamiota request AMM to lobby the Federal and Provincial Governments to create a fund that would be made available to municipalities to undertake feasibility studies for the purpose of obtaining Water Rights Licenses.***

***AND BE IT FURTHER RESOLVED THAT the proposed funding would be made available on a cost sharing basis.***

#6 Lawn – Arnold

***WHEREAS the regulatory body for pesticide (chemical & non chemical) in Canada is Health Canada's pesticide Management Regulatory Agency (PMRA). PMRA puts all pesticides through a rigorous scientific assessment process to ensure their safety for Canadians of all ages. Science is the basis for all Health Canada regulatory decisions for pesticides***

***AND WHEREAS a pesticide can only be registered or remain registered in Canada if any associated risks have been determined with reasonable certainty that no harm to human health, future generations or the environment when used as directed.***

***AND WHEREAS the 8 most commonly used Home & Garden active ingredients have undergone a rigorous re-evaluation process recently in Canada, European Union and the United States without significant changes in their use.***

***AND WHEREAS the Study most often quoted with regards to human health and cancer is the Ontario College of Family Physicians report of April 23, 2004. This study has been determined by several noteworthy science based organizations to not stand up to scientific rigor.***

***AND WHEREAS in other Provinces the ban has made an underground trade in pesticides and homeowners are forced to break the law by buying products from across the border or from their rural friends. This would lead to the possibility of greater use of unregistered products and a greater likelihood of unsafe pesticide applications.***

***AND WHEREAS bans that ignore the scientific evidence that existing federal regulations are based on can actually jeopardize the health & safety of the very people a government says they are trying to protect. Untested, unregistered and potentially unsafe products will be used. Infusions of rhubarb leaves or tobacco leaves in water sprayed in the garden are commonly made. This homemade pesticide is also toxic to humans and in most cases more toxic than the pesticides they are replacing.***

**AND WHEREAS an increase in weed populations and resulting pollen have been reported to adversely affect people with allergies and adding to health care costs.**

**AND WHEREAS according to a May 27, 2011 CBC story, the Manitoba Roundtable for Sustainable Development has recommended a ban to the Minister of Conservation. It was reported by CBC said that the Roundtable April report said Manitoba should prohibit “the non-essential cosmetic use of chemical insecticides, herbicides, and fungicides for residential, institutional and recreational facilities near water and all urban and rural areas”.**

**AND WHEREAS a cosmetic pesticide ban would adversely affect municipalities in Manitoba by increasing the cost of noxious weed control required under the Noxious Weeds Act. Also weeds in urban areas act as an abundant seed bank to infest surrounding agricultural and other natural areas. Sports fields & parks in particular would become difficult to maintain to a safe standard which would lead to sports injuries and personal injury claims.**

**AND WHEREAS a cosmetic pesticide ban would also adversely affect producers as their costs would also increase from additional weed infestations from these urban areas. Additionally as pesticides are continued to be used by producers but pesticides are considered, but not proven, to be “unsafe” for people, producers would be negatively impacted.**

**THEREFORE BE IT RESOLVED that the Rural Municipality of Hamiota request that the Provincial Government not implement legislation on a Cosmetic Pesticide ban as they are not based on scientific knowledge and have a high likelihood of having a greater adverse impact on the residents of Manitoba.**
